# PART IV: ADDITIONAL INFORMATION

In an open procedure for public procurement of medical consumables and contrast media published on the public procurement portal under the number: 867-1-1-60-3-49 / 17 of 24 April 2017, the correction of the procurement notice number: 867-1-1 -60-8-60 / 17 of 02.06.2017, and the correction of the procurement notice number: 867-1-1-60-8-103 / 17 of 31.08.2017, the interested bidder filed an appeal on the Tender Documentation which was forwarded to the BiH Appellate Body of BiH as an unfounded Contracting Authority.

By resolving the complaint, the Office for the Review of Appeals issued a decision rejecting the appeal as unreasonable because the Appellant did not submit evidence on the payment of the administrative fee and the fee for conducting the appeal procedure.

In this regard, the contracting authority continues the procurement procedure and has made changes to the tender documentation regarding the deadlines for submitting tenders and public opening for this purpose.

Bids that have previously been received by the contracting authority will be accepted and their opening will be made in accordance with the published new deadlines and dates.
